December 16, 2025

Mayor Roberson called the meeting to order at 7:00 p.m.

ROLL CALL FOR ALDERMEN IN ATTENDANCE: B. Hull, Hull, Muller, Williams, Walker, Goben

PUBLIC IN ATTENDANCE: Haider Nawaz

CITY EMPLOYEES IN ATTENDANCE: City Clerk Nawaz, Chief of Police Vick

PLEDGE OF ALLEGIANCE: Recited by all in presence.

CONSENT AGENDA:

Mayor Roberson asked for comments and questions for the consent agenda. No questions or objections were stated; the consent agenda was unanimously approved.

Comments from Public: Haider Nawaz gave a shout out to the City for holding an excellent “Holiday Lighting” event on November 29, 2025; attendance was good; food was good and there were many happy faces of children getting toys from Santa. Haider Nawaz stated that all the decorated houses around town look beautiful.

NEW BUSINESS:

Approval of Document Destruction Lists #30: City Clerk submitted Records Destruction Lists #30 (Attachment 2). Listed documents were past the retention period in accordance with the Missouri Municipal Records Manual retention schedule.

Alderman Muller moved that the City Clerk/Custodian of Records is hereby authorized to have the records and documents shredded or recycled as per the records destruction list #30, submitted to the Board on December 16, 2025. Seconded by Alderman Hull. Motion passed unanimously.

Hiring Police Officer: Chief Vick introduced Gary Kerley, a former Grandview police officer for fifteen years; has known Chief Vick for the past 23-years and has a real estate business. Chief Vick informed that Kerley has reinstated the POST certification; recommended hiring Kerley for up to 20-hours a week shift. Chief Vick stated that the said position is within the budget. In response to Alderman Hull’s question, Chief Vick stated after the training period, their shifts would be overlapping. Upon Seargent Shepherdson’s return Kerley will assume 20-hours a month shift.

Alderman Muller moved to hire Gary Kerley for the position of part-time Police Officer, up to and no more than 20-hours a week, starting salary \$17.00 per hour; review to follow the 90-days probation period. Hiring date effective from Thursday, December 18, 2025. Seconded by Alderman Williams. Motion passed unanimously.

Central Square Program: Alderman Muller stated that he received input from some other cities' police department personnels who are using the Central Square program; it is a very useful program as long as it is running properly; seems like there are still some glitches. Alderman Muller hoped that all the system glitches are removed before Cleveland Police Department starts to use the said program.

Questions/Comments Reference to the Meeting Held on November 18, 2025: Alderman Goblen asked if the complaints about the Chief of Police were about doing his job? Mayor Roberson answered in affirmative and stated that is why body cameras are a good thing for the police and complainants' protection. Alderman Williams stated that he found the bylaws for the Lazy Y Subdivision and thanked Alderman Muller for the guidance. Mayor Roberson stated that he has brought the GL correction mentioned by Alderman Hull to the Accounting Clerk's attention.

INTRODUCTION/ADOPTION OF RESOLUTIONS/ORDINANCES (Roll Call)

Bill No. 596: AN ORDINANCE OF THE CITY OF CLEVELAND, MISSOURI TO DETERMINE WHETHER TO FORGO ANNUAL MUNICIPAL ELECTIONS FOR A PERIOD OF SIX YEARS IF THE NUMBER OF CANDIDATES FILING EQUAL THE NUMBER OF SEATS UP FOR ELECTION IN ACCORDANCE WITH SECTION 115.124 RSMo.

Points of Discussion: (1) Concern about the Write-in opportunity. (2) Concern about the lack of advance education for the said Bill 596. (3) Opportunity to save election costs. (4) Ask other municipalities about their experience of this. Following discussion, it was decided to take Bill No. 596 off the agenda.

Bill No. 597: AN ORDINANCE OF THE CITY OF CLEVELAND, MISSOURI, IMPOSING A USE TAX FOR GENERAL REVENUE PURPOSES AT THE RATE EQUAL TO THE TOTAL LOCAL SALES TAXES IN EFFECT FOR THE PRIVILEGE OF STORING, USING OR CONSUMING WITHIN THE CITY ANY ARTICLE OF TANGIBLE PERSONAL PROPERTY PURSUANT TO THE AUTHORITY GRANTED BY AND SUBJECT TO THE PROVISIONS OF SECTIONS 144.600 THROUGH 144.761 RSMO; PROVIDING FOR THE USE TAX TO BE REPEALED, REDUCED OR RAISED IN THE SAME AMOUNT AS ANY CITY SALES TAX IS REPEALED, REDUCED OR RAISED; AND PROVIDING FOR SUBMISSION OF THE PROPOSAL TO THE QUALIFIED VOTERS OF THE CITY FOR THEIR APPROVAL AT THE GENERAL ELECTION CALLED AND TO BE HELD IN THE CITY ON TUESDAY, APRIL 7, 2026.

Discussion held. Alderman Muller stated that imposition of "Use Tax" has been discussed in past and he is in favor of it. Alderman Williams stated he is in favor and recommended an aggressive education plan to make the voters understand the intent. Alderman Hull suggested mailer from the City. Mayor and Alderman Goblen cautioned "City can educate but not advocate". Mayor Roberson stated that City Attorney would be asked to review the City mailer and Missouri Municipal League (MML) can also provide guidance.

Alderman Muller moved to do the first reading of Bill No. 597 in its entirety. Seconded by Alderman B. Hull. Motion passed unanimously.

Alderman Muller moved to adopt Bill No. 597: **An ordinance of the City of Cleveland, Missouri, imposing a use tax for general revenue purposes at the rate equal to the total local sales taxes in effect for the privilege of storing, using or consuming within the City any article of tangible personal property pursuant to the authority granted by and subject to the provisions of Sections 144.600 through 144.761 RSMo; providing for the use tax to be repealed, reduced or raised in the same amount as any city sales tax is repealed, reduced or raised; and providing for submission of the proposal to the qualified voters of the City for their approval at the General election called and to be held in the City on Tuesday, April 7, 2026., as Ordinance No. 025-008.** Seconded by Alderman Williams. Motion passed.

Alderman Muller/ Financial Advisor: Reported:

1. Rolled over a CD of \$75,000 at 3.750%. Alderman Muller reported that over the one-year City has earned \$1,500.00 in interest from the investment CDs, which equates to a little over 4%.
2. Alderman Muller informed that City has \$298,000 in General Fund and \$ 110,000 in water fund available for disbursements.
3. City has received November 2025 financial report from the CPA; City is mostly within the projected budget, only exception is that sales tax at this point is 39% whereas by December sales tax is usually 50%. City should be OK as long as there are no unplanned expenses.
4. Noticed that the financial reports for General Fund in November and October showed no value for equipment and assets. He will have the accounting clerk investigate that.
5. Completed the cut-out deer and trees decorations for the Main Street. City Clerk thanked Alderman Muller for the said decorations.

Alderman Hull: Thanked Alderman Muller for watching out for the City's financial picture and investments; said it is very helpful. Alderman Muller stated that he enjoys doing accounting and watching over investments as one of his retirement hobbies.




